- Lots can be exited based on Farmer / Trader / CA / Lot wise farmer


Sale Agreement / Sale Bill Cancellation:

This option is Current, and this is useful in cancellation of Sale Agreements / Sale Bills based on different situations.

In case of unsatisfied terms and conditions and wrong details entry we can cancel the Agreement and Invoice. If Sale Agreement and Sale Bill is generated, we need to cancel Sale Bill first and then Sale Agreement. The cancellation status will be reflected in reports also.
