 3. Detailed Rules and Conditions and Security Deposit amount etc.--
 1. Eligibility--Any trader desiring to operate in more than one market area is eligible.
 2. Documents required -- a) Form -"1 A" in prescribed format
 - b) List of Agriculture Produce Market Committee in which trader desires to operate.
 - c) Bank Guarantee of Rs.5,00,000/-lakhs
 - d)Solvency certificate
 - e) Licence fee Rs.500/- per Agriculture Produce Market Committee.
 - 3) How to apply--Any person who desires to apply for unified single licence should submit all above documents to Director of Marketing, Maharashtra State, Pune-411001.
